

# **Tender Specifications for the Enhancement of Gin Drinkers Bay cricket ground (Ref. No.4023C/06(19))**

## **1. GENERAL**

1.1. Construction and improvement of sports facilities, and procurement of sports equipment for the promotion of sports development in Hong Kong.

1.2. Construction and installation of drainage cover

1.3 Removal of Light poles

1.4 Installation of practice cage

1.5 Installation of rolling mat

## **2. SCOPE OF SERVICES**

### **2.1. Staff Requirements**

The Appointed Contractor shall deploy staff who:

2.1.1 Possess knowledge and experience in construction and installation of structures to promote health and safety to users.

2.1.2 Possess skills and experience to facilitate removal of structures minimizing damage to landscape

2.1.3 Have knowledge to procure sports facilities suitable to the required standards of training and performance

2.1.4 Have knowledge in safety precautions whilst working on site.

### **2.2. Responsibilities of the Appointed Contractor**

The Appointed Contractor should be responsible for:

2.2.1 The contractor shall make its own arrangement to remove any earth, spoil, debris, construction waste or building materials from the site and make good any damage done to the Government properties.

2.2.2 The contractor will comply with all requirements set out in the land licence agreement (Temporary cricket grounds at Gin Drinkers Bay Landfil)

2.2.3 An agreed timeline with Cricket Hong Kong China must be in place. No Major works can take place on a cricket pitch at the same time a cricket match is being played on that specific pitch. Cricket Hong Kong China require completion of the project before the 31<sup>st</sup> December 2023.

2.2.4 For the safety and convenience of the public, players and spectators and all persons on or in the vicinity of the Licence Area, the contractor shall take all reasonable steps to avoid any accident, injury, nuisance or damage to any persons or properties whether directly or indirectly arising out of or in connection with enhancement of facilities work

2.2.5 An Authorised Person 'AP' will oversee quality assurance process to ensure that construction work meets specified standards and requirements. They will conduct inspections, review construction plans and specifications and verify that the work is being carried out according to approved methods.

2.2.6 When any Construction Works have been substantially completed and have satisfactorily passed any final tests, the Licensee may serve notice in writing to the GM of Cricket Hong Kong China certifying that the Construction works have been completed in full accordance with the design and the methods of construction consented by the General Manager and the Facility is in a state ready for the safe and secure operation.

2.2.7 The contractor shall submit a safety plan and method statement before commencement of work." under 2.2

### **3. PROJECT DESCRIPTION**

#### **3.1. Construction of drainage cover**

3.1.1 For the protection and prevention of injury to cricket players at the GDB site Cricket Hong Kong China are requiring the cover of the pitch boundary drain under the approval from EPD.

3.1.2 Permission has been granted to cover the drainage channel only (no filling allowed)

3.1.3 The Appointed Contractor shall provide a designed cover for the drainage channel that will provide a secure and safe option to cover the drain without disruption to surface water flow

3.1.4 Tender applicants may arrange a site visit by calling the Cricket Hong Kong China office and arranging with the appointed person

3.1.5 The drain covers must be fixed and durable to withstand up to 300kg in the event of persons landing on or walking on the cover

3.1.6 The contractor will provide an initial 6 months repair and replacement cover for any drainage cover damaged.

3.1.7 The amount of drainage to be cover equates to 700 meters over 2 pitches (See appendix A & B)

3.1.8 At the end of the land lease Cricket Hong Kong China may have to remove the covers. The contractor must ensure there will be minimal damage to the surface walls when removing the drain covers.

### **3.2. Removal of light poles (Appendix C)**

3.2.1. The Appointed Contractor shall remove and dispose of 29 light poles from around the pitch at Gin Drinkers bay cricket ground

3.2.2. The Appointed Contractor shall be required to replace any concrete/soil/grass from the light pole removal to the same level of the surrounding area after the removal of the light poles

3.2.3. The light poles have no connection to electricity or solar panels attached

### **3.3 Installation of Practice cage (2 units)**

3.3.1 Purchase, delivery and installation of 2x cricket practice net cages to Gin Drinker Bay cricket ground (Appendix D)

3.3.2 Non fixed to ground cricket cages required with 4-6 Swivel wheels to allow easy transportation around the ground.

3.3.3 Dimensions required 3m H x 3.6.m W x 7.6m D

3.3.4 Galvanised box section steel frame with Colour: Galvanised frame with black netting

3.3.5 Supplied with one-piece 3mm thick polypropylene netting full attached and installed ready for play.

### **3.4 Installation of rolling mat**

3.4.1 Purchase, delivery and installation of a cricket rolling mat.

3.4.2 Dimension 24m x 1.9m sized surface complete with roll up core, stabiliser edge strips & storage fasteners

3.4.3 Mat will be of a standard capable to roll out and play on all types of surfaces providing true representation of cricket bounce and performance.

3.4.4 Durable surface offering a long lifespan, player comfort and underfoot grip.

3.4.5 Stabilising strips to ensure the mat lies flat.

3.4.6 Built in expansion ports to enable the system to absorb temperature variations.

3.4.7 Metal core for the mat to roll up over for storage and preserving the standard of the mat

3.4.8 Weather resistant sack cover for storage of the mat
